



Terms and Conditions for Bookings

Inclusions and Exclusion

Your booking will include on-board accommodation, meals and snacks, coffee, tea, drinking water, soft drinks and beer, all diving, beach visits and land excursions. It also includes the National Park fees and transportation to/from the airport or hotel.

Inclusions for diving are the service of qualified dive masters, full dive tanks, weights and weight belts.

Wi-fi internet is available and free of charge for our guests.

Each trip includes an international English speaking cruise director.

All inclusions apply for 20 passengers.

The published cruise rate does not include, wine or spirits, tips-gratuities for the crew, dive equipment rental, dive courses (nitrox, advanced, photo, video), use of satellite phone, international or domestic air transportation, hotels and meals before and after the cruise, personal and medical insurances.

Upon request, we can arrange a massage therapist, private guide, lecturer or additional service on daily surcharge.

Salila will be expecting the guests to pay on board expenses (drinks, gratuities etc.) in cash (US Dollar, Euro or Rupiah), at the end of their trip. For extensive land excursions, the Salila may need to charge for additional expenses.

Bookings and Payments

After contacting us with an interest to make a booking, our team will start communication by e-mail to set up your trip and provide you with an itinerary.

Upon your confirmation, you will receive an invoice for down payment of 20% of the total cost of your trip. This deposit is non-refundable.

Unless paid within 10 days after receipt, the Salila will open up your reservation for other customers.

Payment must be done by wire transfer to the bank with details provided on your invoice. The guest must carry any bank costs related to this transfer.

Final payment of the 80% balance must be paid at least 30 days prior to the charter departure date.

For short notice bookings made within 1 month before departure, you will have to pay the full amount due. This final payment is also non-refundable.

Individual Cabin Based Booking Terms

Cabin based charter require a minimum booking of 6 cabins (including 2 master staterooms and 4 standard staterooms) and the booking can be made by multiple agents or brokers.

If the minimum requirement of 6 staterooms for cabin based charter are not booked within minimum 60 days prior embarking date then MV Salila's owner reserves the right to cancel the scheduled departure. In case of cancellation an alternative cruise will be offered and if not acceptable all down payments will be 100% refunded to charterer.

Charter Confirmation Terms

Bookings are confirmed only after Salila has received the deposit of 20% of the cruise fee on the invoice. Rates apply either on a full charter or individual cabin based charter.

The area of operation varies throughout the year to offer optimal conditions for the season. If a cruise is requested outside of these schedules, a re-location fee may have to be charged to the total cost of the trip. The price of this fee will depend on the location of the charter.

Changes of Booking

Any changes of traveling date must be received no less than 3 weeks prior to original embarking date via email with non refundable fees of USD100, and changes are subject to availability

The Salila reserves the option to make unavoidable changes like changes in departure dates due to unexpected changes in domestic flight schedules. They may also include changes to itineraries due to unexpected natural events or political unrest.

The team of Salila will make all effort to communicate these issues fully and to provide acceptable comfortable alternatives in full consultation with the guests.

When a guest wants to leave the trip before its completion, the Salila is not liable for refunds, but will make every effort to facilitate return travel of the guest.

In the case of no-show all fees are forfeited and not returned to the guest

We recommend for all guests to prepare sufficient insurance for emergencies.
